- II. Review of Minutes
 - a. Moved to approve: Lori Cherry
 - b. Seconded: Dr. Rebecca Foster
 - c. Approved
- III. Report of Chairman
 - a. Nothing new to report.
- IV. Medical Director's Report
 - a. Dr. Chizmar, State Medical Director
 - i. Protocol updates are online on the online training center.
 - 1. A few revisions needed have been noted.
 - a. EPI infusion: Start at 1ml/min & titrate to 10. Now revised to go up to 2ml/min
 - i. Epi has lower complications than dopamine.
 - ii. Want to keep the math as simple as possible.
 - iii. 1mg in a 100ml bag (not 1000 anymore) Start at 60gtts/1drop per second. Increase to 2 drops per second.
 - Drip beyond that is not likely to have a positive BP effect. If still a need, get medical consult.

- b. Revision document will be out today. All the printed material will have corrected information.
- c. Update can be watched on Youtube, on Scorm, etc. We ask that the clinician log into the MIEMSS LMS & take the quiz to show they completed it.
- ii. Fully Licensed pathway is being created.
 - 1. Provisionally Licensed 150 paramedics and over 700 EMTs.
 - 2. Must complete Continuing Education within 6 months of provisional expiration.
 - a. Requirements depends on how they obtained their provisional license.
 - i. Student
 - ii. Lapsed
 - iii. Reciprocity.
 - b. We value their contribution and wish to retain them.
 - 3. Davidson: does con-ed taken after receiving the provisional license apply? Chizmar: yes, we will go back 12 months for the training. Will look to EMSOP leaders to confirm the clinicians have been practicing.
- iii. Hospitalizations below 1000 which is good.
- iv. Alternate destinations for COVID are open with at least a 6-month plan.
 No immediate plan to demobilize them (convention center Adventist ACS, etc.).
- v. Leaving Pandemic Triage Protocol in place for the time being
- vi. We have tests available for clinicians
- vii. We are working on longer range initiatives as we normalize.
 - 1. EMS Plan
 - 2. State/Local content for ALS recertification update. Content will be online shortly.
 - 3. Seeking to replace the ALS protocol test with an online protocol orientation and test. For new licensees that have NREMT.
- viii. Roger Stone: Any Update with CHATS?
 - 1. Chizmar: @HA is in Beta test: helps clinicians determine wait times at facilities.
 - 2. Working on notification system actively. Evaluating platforms.
- ix. Dr. Stone: Anything EMS relevant from the 2020 legislative session.

- 1. Chizmar: Nothing specific was passed that relates to us. Going into the next session, we will be seeking to amend the vaccination protocol to include a COVID vaccine as it comes out.
- 2. Helmet Law repeal will be attempted in the next session.
- Legislation may be put forward that COVID is a workplace illness for fire/EMS. MIEMSS can't take an official position on any legislation but we can provide support in the form of data.
- b. Dr. Stone, Region V Medical Director
 - i. Old Business
 - 1. Reimbursement for non-transport work of EMS
 - a. **ET3 applications (Four jurisdictions) awarded**: Implementation Fall
 - b. Annapolis & Baltimore Cities, Charles & Montgomery Counties
 - c. No Change: HSCRC and Individual payors remain situationally aware
 - d. MCFRS filling out Guidance Template requirements by MIEMSS
 - 2. Alternative Transport Destinations: On hold due to Pandemic
 - 3. CHATs MIEMSS still engaged in advisory and dynamic system proposal
 - a. Any update from Region V administrators?
 - i. Dr. Pinet Peralta: We're still testing the @HA system and it's ongoing.
 - 4. Will ask Dr C if report exists on Statewide Summit Glen Burnie 11/14/19
 - a. Cyndy Wright Johnson: There will be a follow up QI Summit. The original plan was to have it as part of the medical Director's Symposium which has been postponed. If we can't gather in a safe location, it will be done in phases versus as an online meeting that would exceed 6 hours.
 - Planning shorter quarterly meetings and form a QI group.
 Trauma and Pediatric QI Committees already exist. Should make one for EMS.
 - c. All comments and input have been reviewed and the plan is to go through and prioritize the suggestions and comments.
 - 5. Base station Instructors: Ft Washington disrupted by COVID planning and meetings
 - 6. EMS Plan 2020 Plan write-up on 12/18/19 Summit (will ask Dr. D)
 - 7. <u>COVID-19</u>
 - Epidemiology beyond scope of this meeting BUT: Hospitalizations < 900
 - b. PSAP screening continues

- c. PUI continue to decrease but suburban Region still has high acuity
- d. Hospitals STILL linger on ICU census: PG and MoCo packed
- 8. 2020 Legislative Session Dr. Chizmar can update any main bills
- 9. Mid-Atlantic Transport Conference still scheduled 10/2/20
- 10. Direct to Triage: We estimate 5% qualify but numbers could be higher

 - 1. COVID 19: Flatten Virus curve but "bulging curve on regular pathology"
 - a. Statewide MIEMSS ID calls now bi-weekly, next 6/24/20
 - b. Statewide PSAP calls bi-weekly, next 6/16/20

 - a. No more Dopamine; Epinephrine drips (ALS)
 - b. Nasal Inhaled Alcohol for nausea (BLS)
 - c. Pediatric TOR (All levels)
 - i. Cyndy Wright Johnson, further training available through EMSC Champions.
 - ii. There is a 30 minute video on pediatric TOR that can be made available by request at pepp@miemss.org
