Call to Order

Meeting opened at 10:00 AM by welcoming attendees. Having been duly convened, the committee was ready to proceed with business.

The meeting proceeded as follows.

Discussion

BLS Recertification Cycle

• Mr. Buckson discussed that the BLS recertification window for those who must recertify by 12/31 will open on 1 October. This opening of the application window mirrors the method employed for ALS recertification already in place.

eLicensure Update

- This will be an eLicensure workgroup meeting tomorrow (20 September 2018) in which Terrell will be demonstrating several changes in the system. He will be sending out an agenda to all committee members this morning.
- The system will now allow service directors to delete providers from their systems without involving MIEMSS. This action can be taken on an individual basis or through a bulk removal. Mr. Buckson has instructions to complete this task and can make them available as needed. Additionally, he will be demonstrating this function at tomorrow's eLicensure meeting.
- Mr. Buckson also reported that functionality has now been added to allow the
 bulk import of training completions into the Licensure System continuing
 education records. This is in addition to the previous functionality that allowed
 for the adding of individual records one at a time. This will also be demonstrated
 at the eLicensure meeting tomorrow.

ALS Coordinator Position at MIEMSS

Mr. Buckson announced that the advertisement for the ALS Coordinator's
position in MIEMSS Office of Licensure and Certification has been extended
until 1 October 2018. He asked that if anyone knows of someone who is both a
paramedic and MICRB approved who may be interested in the position, please
have them apply.

State/Local NCCP Requirements

- Pete Fiackos lead a discussion regarding the State/Local content that is being developed as a training option for providers across the state to meet 10 of the required 15 hours of state/local content. Mr. Buckson stressed that Dr. Alcorta has remained staunch on the fact that the 9 state required content hours must be completed rather online or in a classroom. The content is being developed:
 - Technology: AA County is developing 1.5 hours of online content. They
 hope to have their program ready for review by the second week of
 October.
 - Mobile Integrated Health: Queen Annes County is developing 1 hour of content.
 - o MOLST: Montgomery County is producing 1 hour of content. Rae Oliveira reports a few delays and Pete Fiackos will reach out to assist.
 - o SAFE: Baltimore City is developing 1 hour of content. Although not at the meeting, Colleen Lull has reported some delays as they are having difficulty getting connected with their hospital source for SAFE.
 - Emerging Infectious Disease: UMBC content is already live on MIEMSS
 Online Training Center. Completion of this 5-hour course will provide the
 learner with 1 hour of state/local required content and 4 hours of
 individual content.
 - Potentially Volatile Content: Howard County is in the process of developing 1 hour of content and is in the final review stages.
 - Elite General Overview: Program is already live online and will provide
 0.5 hours of Local/State required content.
 - The remaining 3 hours will be met by the completion of the protocol updates for a total of 10 out of the required 15 state/local content hours.

PDI

Pete Fiackos announced that the EMS Education Symposium PDI offering will be
offered on an Odd/Even year schedule where it will be hosted at MFRI on even
years and it will be hosted at another location on odd years. This coming PDI
program (10 January 2019) will be held at Chesapeake College. The keynote
speaker will be Mr. William Seifarth, the new Executive Director of the National
Registry.
