 - i. Person to Person seems to be indicated in the NCR. MDH believes it to be imminent
 - ii. MIEMSS Recommends N95 to all clinicians within 6 feet of a patient or providing respiratory procedures to patients.
 - iii. If you are running out of N95s use surgical facemasks on self and patient.
 - iv. Surgical Masks recommended for patients who are PUIs
 - v. Positive COVID-19 transport to Hospitals have occurred & the EMSOPs will be notified of possible clinician exposure.
 - vi. Exclusion from Work Criteria will be covered in tomorrow's webinar for clinicians who've been positively exposed without PPE
 - vii. Educational programs: We are recommending students receive the same PPE and we are NOT waiving the field internship requirement.
