### **MIEMSS Report:**

John Barto:

CHESAPEAKE REGIONAL INFORMATION SYSTEM FOR OUR PATIENTS, INC. - CRISP Allows access to patient records for EMS and ER doctors before, during and after transport.

Notification CRISP integration – moving to make available as a part of elite integration.

MIEMSS is requesting that jurisdictions sign the agreement now (deadline 12/31/19) so that they will be eligible for the second and third phase of the CRISP integration. On February 8, 2019 from 1:30pm until 3:30pm, a webinar program will be hosted by MIEMSS to provide additional information.

Dr. Chiccone and Dr. White are very interested in the CRISP process and are supportive. Dr. White indicated that the system was not perfect. Still missing data and has potential for not matching patients correctly.

Anna Sierra indicated that all heath care information would be in CRISP so that the patients' medical history can be tracked and shared with EMS and ER Doctors.

John Barto:

Confirmed that Dr. Delbridge would become the Executive Medical Director on February 13, 2019 and added that the MIEMSS staff would be meeting him at the staff meeting on February 14, 2019.

He also indicated that Dr. Chizmar would have attended our Region IV Council meeting today if not for the joint EMS board / SEMSAC meeting. Will work on getting him here in the near future.

Wanted to remind everyone that affiliation requests would need to flow through proper channels to make sure they are being received at the company level. Please verify any jurisdictional changes so that affiliations are verified promptly.

## **Regional Reports:**

Mary Alice Vanhoy indicated that Winterfest is fast approaching. Registration is still open but filling up quickly. There are still a few spots left in the skills class. Excellent opportunity for BLS to get all continuing education and skills needed for recertification. Dr. Chismar will be a speaker at the conference.

Sgt. Mike Mann, MSP Aviation Command:

Had great things to say about Dr. Chismar.

Mike admits that he has missed a few Council meetings and apologizes.

He wanted the Council to know that the media coverage has not been accurate – Trooper 6 has been staffed over the past year. The MSP has had a number of call-ups from the military and several pilots were called to serve. Additionally, some aviation staff left for other reasons and have since decided to come back.

There are still vacant spots that need to be filled. This is being worked on and we are on our way to being well staffed.

We are a system – just because your local aircraft is not available does not mean there is not anything available. Call SYSCOM and we will get a helicopter to assist you.

Brian LeCates thanked Sgt. Mann for explaining this to the Council and indicated that we do not determine if we are flying out based on whether Trooper 6 is available. We have also taken the time to educate our officials on this point.

Anna Sierra stated that she has received emails from some of the local Fire Chiefs expressing concerns.

Mike Mann indicated that we are always willing to come out to a meeting and explain things to those with concerns. Thank you all for the great support and understanding, we always want to deliver what is needed to EMS, Fire, etc...

Anna Sierra provided an update on the Dorchester County 911 center relocation and radio system.

#### **Old Business:**

John Barto:

Survey Monkey Nerve Agent Antidote - all responded very quickly after the last council meeting, Thank you!

50/50 Grants - Until the purchase orders are signed off on, approved and sent, no letters will be sent to those who were not funded. We had \$91,000.00 in available Grant money and \$441,000.00 in Grant requests.

We are looking to Regional Affairs for the potential to obtain extra funds. We are pushing for this to happen but we have no timeframe as to when this may occur.
