To All Maryland EMS Clinicians:

Re: The Maryland Medical Protocols for Emergency Medical Services - 2022 additions, updates and revisions

EMS clinicians will be able to download the full protocol document from the MIEMSS website at www.miemss.org and will receive a single copy of the 2022 pocket protocols.

The EMS Board has approved these protocols for implementation on July 1, 2022. Prior to July 1, all EMS clinicians must complete the Maryland EMS Update: 2022, which will highlight the new material. The protocol update will be available for continuing education credit on the MIEMSS Online Training Center (www.emsonlinetraining.org) in mid-May 2022.

With multi-disciplined input, we have updated the protocol content to reflect best practices and evidence-based medicine. The list of these changes is for reference only, and the information contained in the full protocol book is the official medical reference for EMS clinicians in Maryland.

A summary of significant protocol changes:

- Acetaminophen: All patients ages 3 months and older may now receive acetaminophen for treatment of fever (EMS-documented temperature of 100.4 or greater) or mild to moderate pain.
- Cardiac Arrest (Adult): The Adult PEA/Asystole algorithm has been refined to provide focused guidance on the management of patients in asystole, PEA with a narrow QRS, and PEA with a wide QRS. Calcium chloride and sodium bicarbonate should only be given for PEA with a wide QRS. The medical consultation requirement for sodium bicarbonate administration in adults has been removed.
- **Critically Unstable Patient (Adult):** A critically unstable patient protocol has been added to the General Patient Care section. This protocol emphasizes resuscitation of unstable patients on-scene prior to initiating transport.
- **Direct to Triage:** This protocol defines stable patients who may be suitable for direct transport to triage upon arrival to the receiving emergency department.
- **Droperidol:** This medication replaces haloperidol for treatment of patients who are 13 years of age or older presenting with moderate agitation.
- Extraglottic Airways: This addition to the Procedures section allows for the use of extraglottic/supraglottic airways including the King LTS-D, LMA, Air-Q, and iGel. An EMS operational program must select one of these airway devices and carry sizes appropriate for all patients from newborn through adult. These devices serve a critically important role in assisting ventilation and oxygenation to patients with compromised airways.
- Induced Hypothermia: Based on recent high-level scientific evidence, induced hypothermia has been removed.
- **Lateral Uterine Displacement:** For pregnant patients with hypotension or cardiac arrest, specific guidance has been added to provide left lateral uterine displacement with a goal of increasing venous return.
- Tranexamic Acid (TXA): TXA has been added to the protocols for treatment of traumatic hemorrhagic shock in patients 15 years of age and older.
- Ventricular Assist Device (VAD): Specific guidance has been added for the management of unstable patients with VADs.
- Optional Supplemental Protocol: Hydrofluoric Acid: Due to increased risk of HF exposure from electric car
 batteries, this OSP has been added to allow for calcium gluconate via IV, topical and nebulized routes.
 Interested jurisdictions should submit an OSP application to the State EMS Medical Director.

PEMAC UPDATE –May 2022 The CPS & OP Healthcare Project

- The CPS project to distribute car seats to needy families across the state continues with
 participation among EDs, the MCH departments of several hospitals, and a few Safe Kids-Maryland
 partners. Three other hospitals MCH departments have expressed interest and become partners
 in the near future.
- The CPS workshop for newborn nursery and NICU nurses occurred on April 26th. A total of 44 nurses from 25 hospitals attended the two back-to-back sessions. (51 were expected from 27 hospitals). We also had 6 nurse-CPSTs from 5 hospitals and one person from MD Kids in Safety Seats help run the workshops. The final evaluations are not tallied yet but informal comments suggest the attendees really found the workshops valuable. We also invited attendees and applicants who weren't admitted for the in-person listen to two online lectures; they could receive one contact hour from the Maryland Nursing Association for each webinar and 3 contact hours for attending on 4/26. 85 have listened to the two webinars as of May 2nd.
- Helped at a car seat distribution at Mile One Auto in Catonsville with MD Kids in Safety Seats.
- Finalized a new handout: "Car seats save lives in cars, but what about outside the car?"
 Laminated versions of this will soon be available or go to www.miemss.org/home/emsc/cps
- Attended Lifesavers National Traffic Safety Conference in Chicago.
- Attended the Maryland Highway Safety Summit, and also conducted an exhibit on CPS.
- Received 4 applicants for the project to get All-in-One car seats for 20 EMS supervisors' vehicles
 for non-emergency transport of children (Ocean City, Calvert Co, Allegany Co, Washington Co).
 We will follow up with those applicants in the next week or two, and they should receive their
 seats by the end of June.
- Helped teach two Child Passenger Safety Technician certification courses (Salisbury and Lexington Park). Other courses are scheduled. Anyone interested in upcoming course can go to www.cert.safekids.org to get automated alerts when new classes are scheduled. Scholarships for the \$95 registration fee are available on a limited basis.
- Posted a number of social media messages on traffic safety themes.
