## MIEMSS Dedicates New Building To John Murphy, Conference Center to Richey Adams

On January 12, 1999, MIEMSS celebrated the official opening of its new central office at 653 West Pratt Street by dedicating the state building to John M. Murphy, Administrative Director of the agency. The Conference Center in the new MIEMSS building was dedicated to the memory of Richey D. Adams, a former member of the Statewide EMS Advisory Council (SEMSAC), who died in 1996.

Mr. Murphy has worked for the state since 1972, and has worked in EMS since 1983. A pharmacist, he was the Chief Operating Officer of the Shock Trauma Center and trusted advisor to the late R Adams Cowley, founder of the Center and the innovator behind Maryland's EMS system. Through the sometime tumultuous transition after Dr. Cowley's death, Mr. Murphy ensured that patient care was never compromised and that all elements of the system continued to work effectively together.

When the prehospital division of MIEMSS was threatened by severe budget cuts in the early 1990s that would have rendered the agency ineffective, Mr. Murphy worked to secure special funding for MIEMSS and other EMS agencies.

When MIEMSS was reorganized by Governor William Donald Schaefer in 1993, Murphy was responsible for its implementation that moved the agency from the University of Maryland System into the state bureaucracy. He served as administrative head of the agency and the newly formed Governor's Emergency Medical Ser-

vices Board. Since then, he has served as the agency's main contact in Annapolis, and has been successful in gaining support for upgraded EMS communication, training, and Med-Evac coverage.

Mr. Murphy was in large part responsible for the agency's move into the new building, and worked with the University of Maryland and the University of Maryland Medical System on building funding, design, and construction. The agency never had a permanent home through the 1980s and 1990s, moving through six buildings on the University of Maryland, Baltimore campus.

Donald L. DeVries, chairman of the EMS Board, summed up the feelings of many of those attending the dedication: "With all of this, however, it is the acts of personal kindness, the compassion, and the good humor that will stand out most with me, and

I am sure most of you, when we recall his remarkable career."

Many people associated with Mr. Murphy through state government and EMS over the years attended the ceremony on January 12. Speakers included former Governor Marvin Mandel, Treasurer Richard N. Dixon, and Delegate David Rudolph.

Richey Adams, to whom the Conference Center was dedicated, was a journalist, a television producer and editor, and a consultant. He was



This year we are again opening the award nomination process to everyone who receives the *Maryland EMS News*. Awardees will be selected by the Regional Affairs Committee of SEMSAC. *The categories of Maryland Star of Life, Maryland EMS Citizen, and EMS Provider of the Year relate to specific incidents occurring from March 1, 1998 to February 28, 1999. Multiple awards may be presented.*

## **MARYLAND STAR OF LIFE AWARD**

This award may be given to an individual, multiple individuals, or teams on the same incident for an outstanding rescue by EMS personnel.

## **MARYLAND EMS CITIZEN AWARD**

This award is intended for citizen rescuers who have demonstrated quick thinking, fast action, and heroism.

## **EMS PROVIDER OF THE YEAR**

For a provider who has made outstanding contributions in the past year to the continuous improvement of emergency medical services in Maryland (for example, in the areas of quality assurance; public or EMS education; prevention; delivery of EMS services; new technology).

*One award for each of the three categories below will be selected by the Regional Affairs Committee of SEMSAC. Nominees not selected will be sent to the Regional Councils for possible recognition at that level.*

## **OUTSTANDING EMS PROGRAM**

For a program that offers an innovative approach to reducing death and disability. The program must be affiliated with an EMS system component, such as a hospital, educational facility, rescue squad, or EMS organization.

## **OUTSTANDING SERVICE AWARD**

For an individual who has dedicated his/her professional life to the prevention of death and disability through outstanding contributions to the development and continuous improvement of the EMS System.

## The Program

EMS CARE '99, the 16th annual statewide conference for EMS providers, is a program designed to meet the needs of field providers. Throughout the program you will see YAWA which means "you asked, we answered." Each area with YAWA is in response to survey data, brainstorming, or other research on provider needs. This includes "ALS only" programs, instructor offerings, and repeats of our most popular programs to ensure access to more participants.

## Continuing Education

Categories and hours are listed under the program descriptions. The first listing is for EMT-B credits (M, T, or L); the second, for CRT; and the third, for EMT-P.

## EMT-B Recertification

The conference workshops are arranged to provide the 12 hours of continuing education required as part of EMT-B recertification. To assist you in determining your credits, we have included a worksheet.

## Registration Fees

EMS Care '99 is the deal of the century. Costs for the two-day conference for Maryland EMS providers will remain at \$120 for the third year in a row. This includes all expenses for workshops and printed materials. Continental breakfasts, lunches, and refreshment breaks are also included. Out-of-state registration is \$150. Fees for pre-conference programs are listed following each program.

Pre-registration is required. We will accept registrations received in the Region V Office by April 16, 1999, or until the conference is filled—whichever comes first. No walk-in registrations will be accepted. Refunds, excluding a \$20 processing fee, will be provided for cancellations received in writing prior to April 18. A \$25 fee will be charged for bad checks. We can invoice Maryland governmental and EMS agencies and hospitals. We cannot invoice federal agencies or out-of-state agencies or organizations. # Pre-Conference Workshops

## April 22-23: 8:30 AM-4:30 PM Incident Management System for EMS

This two-day certification course developed by the National Fire Academy will be presented by the Montgomery County Department of Fire Rescue Services and the Maryland Fire & Rescue Institute {12 hours L, 2, Section II} \$60 registration fee.

### April 23 Pediatric Program for ALS Providers

This Advanced Life Support program is funded through an EMS for Children grant. It is free of charge for Maryland providers, but enrollment is limited. Register early. The out-of-state fee is \$50.

#### Part 1: 8:30 AM-12:00 noon—Pediatric Vascular Access Workshop for ALS Providers

Joseph Wright, MD, Associate State EMS Medical Director for Pediatrics, will lead a workshop on the current practices for difficult vascular access in children and youth. This workshop will include hands-on skill stations taught by members of the Transport Team from Children's National Medical Center. ### Update on 'How Best to Tell the Worst News'

In the October newsletter on EMS Do Not Resuscitate Protocols, we reprinted an article "How Best to Tell the Worst News" that originally appeared in the October 18, 1992 issue of *JAMA* and later in the "Maryland EMS Do Not Resuscitate Program Booklet." John E. Smialek, MD, Chief Medical Examiner for the State of Maryland, responded to the article. He reminds EMS providers to tell the family if the patient's death is within the jurisdiction of the Office of the Chief Medical Examiner (OCME), so that the family does not experience additional distress if the body is not immediately available. EMS providers should also tell the family to contact the OCME at 410-333-3271 (24-hour phone coverage is provided) if they have any questions or concerns.
