Garrett County Activities

Garrett Regional Medical Center - No Report

Garrett County Emergency Services - Wayne Tiemersma

- The ambulance inspections were held the first week of October; all went well.
- Wayne left his position with the County last week to become the new Region I & II Coordinator.

Garrett County Emergency Services Board - Sam Grant; New Emergency Manager for Garrett County

• Since Wayne has vacated his position with us, we now have it posted. If anybody knows someone who might be interested in this position, please send them our way so we can get them an application.

Garrett County Emergency Management & Communications- Justin Orendorf

- The 911 center is at full staffing currently.
- We're still awaiting the release of our funds for the backup 911 radio consoles.
- We are hopeful the Oakland Sang Run tower site will be online by the end of the year. It will help us with our radio system coverage in the western part of the county.
- Also, now looking at an additional site in the Oakland area to help with coverage in downtown Oakland.

Garrett County Health Department - Diane Lee

- The Health Department is currently doing flu shots and will be in the Grantsville office tomorrow.
- We are just starting to get the COVID shots in to use.

Allegany County Activities

Allegany County Emergency Management / Communications - No report

Allegany County Emergency Services Board

- Allegany is changing the alerting around a little bit; doing away with second alerts.
- The Chiefs are meeting this coming Sunday with Steve Shipley to address the new CAD programming issue.

Allegany County EMS - Mike Salvadge

- Lt. Bosley was recently promoted to fill the opening we had. We also promoted 4 new Sergeant positions, which will basically take the place of acting officers. They'll just be permanent officers now.
- Will be moving forward with our training for RSI and actually get that program up and running.
- Are in the infancy stages of implementing Mobile Integrated Health Program.
- We are also moving forward with our peer support group.
- Ambulance inspections will be held next week.

Allegany County Health Department - Allison Robinson

- We are waiting on our COVID shots. But, we're still doing COVID testing Tuesdays and Thursdays.
- We have a new Health Officer, Dr. Junie Delizo. He has been on since the end of June. He is getting involved and in touch with the community.
- Are in the process of revamping all of our Plans.

UPMC Western Maryland - Wendy Helms

- We are now on our second round of interviews for CNO position Jamie Karstetter vacated.
- EDDIE (Emergency Department Dramatic Improvement Effort) is a statewide initiative where all ERs have to come up with a goal for the emergency department to decrease length of stay. Data is sent out monthly to them on admissions and discharges. It also tracks EMS turnaround times in the ER; we are still under the 35 minute mark on that.

Allegany College of Maryland - No report

Regional Reports

Regional Medical Director – Dr. Martin deferred to Dr. Chizmar who covered a variety of topics including updates on the following:

- EDDIE and turnaround time efforts the statewide initiative for ERs.
- Guidance for King Airways and pediatric sizes
- ESPP supplemental payment program to allow EMS to recoup some Medicaid costs
- EMS Board is looking at Limited Scope of Medical Direction regulation
- Legislation regarding vaccinations for both Flu and Covid-19 for the public; action is needed by the General Assembly this year to keep it alive past January 1, 2025. Currently that legislation that enables us to give Flu and Covid vaccines to members of the public sunsets on January 1, 2025.
- QA topic patient is not in cardiac arrest yet when ambulance gets there, and then goes into cardiac arrest at some point, but equipment has not been taken to patient's side. Need to resuscitate the patient where we find them, so take equipment in with you for chest pain or respiratory distress type of calls.
- Patient in prone position please spread the word that we don't want to be positioning patients in a prone position for any length of time during the transport. If they are positioned in that way or they find themselves rolled over onto their stomach for any reason, we want to make sure to get them into the face up position as soon as possible.
- Out-of-hospital cardiac survival rates
- Proposed EMT renewal regulation will slightly decrease the amount of hours it will take to renew an EMT license in the state every three years

Region I Specialty Centers – Jeff Hobbs

The Trauma Center underwent re-designation last month and are good for another 5 years.

MFRI – Todd Dyche

A handout was provided on EMS classes in the Region.

Medevac – Rick DeVore

- They have implemented the early activation policy with all of their aircrafts. Clinicians and dispatchers are activating the aircraft early and are definitely seeing a quicker response especially out in the east side of the county. We've increased our numbers, and are cutting down on those transport times.
- 0+ whole blood was placed on the aircraft this year; have transported over 40 patients command-wide where whole blood has been administered; it is showing a positive outcome. Trooper 5 has done five of those administrations.
- Trooper 5 has done 8 aerial/hoist rescues this year. That's over half of the aerial rescues command-wide.

- We also worked with CFD. They sent out a bunch of their guys to our annual night hoist training this year; trying to build that relationship from the ground up to have guys trained to assist.
- We did a really great outreach with the ski patrol; kind of getting tuned up for the ski season.
- On October 30th, we're doing the not so scary Halloween event. So, if you have kids come up to the hangar for candy and good outreach; normally see over 500 people for that evening.

CISM – Al Ward emailed his report

- They had 2 callouts since the last Council meeting.
- 2 members of team have taken IAFF peer support training.

AGCVFRA - Jonathon Dayton was unable to attend, but emailed an update.

- The MSFA is having a recruitment and retention forum this Saturday. It's not too late to register, more info on the MSFA Facebook and Website. We'll be talking about more than just recruitment so I encourage all volunteers to attend. Mileage reimbursed and free lunch.
- The association is in the process of insurance renewals for some departments.
- The MSFA currently is offering a marketing SAFER grant for member departments, reach out to Chief Tim Dayton if you need more details.
- The next meeting will be at Bloomington in December.

- We hired three new recruits over the last few weeks. They're at the academy and getting things completed.
- We also sent a bunch through paramedic refresher recently.

- As Trooper DeVore said, we sent 15 people from our special ops group of trainees over to train with Medevac.
- We're finishing out the last rope class and we're finishing out Hazmat here in the next few weeks.
- New Squad was put into service about three weeks ago.
- We have seven in paramedic class and one in the hybrid.

Garrett College ALS Training report for Region 1 EMS Advisory Council

October 17, 2023 - 1900 hours UPMC Western Maryland

<u>2022-2024 cohort</u> – The cohort is back in the fall semester. We retain 20 students. The last day of class will be May 7th. NREMT psychomotor testing is scheduled for May 18th. Graduation is set for Tuesday, May 14th at 7 p.m. in the Garrett College Performing Arts Conference room. The Council is invited.

<u>Paramedic accelerated hybrid</u> —This cohort began with 11 students. They meet on Wednesdays from 8 a.m.-5 p.m. for in-person lecture review and skills. All lecture content is online. Following the capstone clinical time, graduation is expected in the first part of September 2024. This cohort will only have the NREMT written exam with no psychomotor.

<u>Fall 2024 cohort</u> — Applications for the 2024-2026 two-year evening program, and the 2024-2025 daytime hybrid program will open in the spring. If interested, contact us to get on the interest list and begin that conversation.

<u>Accreditation</u> – Our 5-year reaccreditation is underway. We completed our self-study and have already received our Executive Analysis. Our site visit is expected in July – December of 2024.

Health Sciences partnerships—The College Presidents from Garrett, Allegany, Potomac State, and Eastern West Virginia Community & Technical College formed an allied health focus group to look at collaborating with multiple programs. Instead of competing against each other, the colleges want to promote each other's programs in disciplines where there is one program in the region. A Memorandum of Understanding was signed by all four colleges on August 28, 2023. With other programs also being talked about, the Presidents chose to use Garrett College's paramedic program as a roadmap. Meetings are ongoing about how a student would come from these other colleges to our program with a seamless handoff. This work is ongoing but expected to be ready when applications open in the spring for the fall programs.
