I. **Opening Remarks – David Sabat:** Chair and Battalion Chief David Sabat welcomed everyone to the meeting.

Chair Report - David Sabat: The minutes from the November 16, 2022 meeting was distributed to everyone electronically and to those in attendance for review. The motion for the minutes for approval were passed.

- A. SEMSAC/Legislative Update Jim Matz
 - 1. SEMSAC had a joint meeting with the EMS Board this month
- B. State EMS Medical Director Report Dr. Tim Chizmar

1. New protocols for 2023 will be presented to the SEMSAC and EMS Board in their February meetings. The protocols include the revision to the clinical criteria to the trauma decisiontry, pediatric respiratory rates and cardiac arrest, indication for the TXA.

2. Protocol updates will include a proposal to add buprenorphine for mobile integrated health programs, Emergency Department Advisory System (EDAS) still working on validation with CRISP and will be announced soon. Hospitals have been meeting throught the state to respond to EMS transfer care process. There are two sub-groups meeting: one group looking into what the expectations are and the second group are looking for the best practices for the hospitals. Many hospitals have drafting and proposing documents and MIEMSS is looking

forward to hearing from the hospitals by the end of the month. 38 hospitals currently receive an EMS transfer care report, including all of the Region III hospitals.
