#### Regional Medical Director's Report: Dr. Chiccone

- •Transcare filed for bankruptcy. Had a contract with UMD and Expresscare. ANR stepped in to fill the void.
- •Protocol Review Committee: Communications section mistake re: consult. Opiods in cardioversion Adults with no consult. 12-lead BLS now optional procedure instead of pilot. TOR Mistakes throughout protocols. Heparin goes to 18g/kg. Terbutaline usage 2015-2016 3k for 12 months; articles have lack in demonstrated benefits likely to be gone for 2017. King Airway "Alternative" airway device rather than last resort of failed intubation. Dr. Seaman recommended setting up subcommittee to consolidate airway to BLS, ALS & difficult. •MICH clone passed; SEMSAC will be longer.
- •eMEDS® to go live Fall 2016.
- •Cyber healthcare summit for hospitals with FBI for Fall 2016.
- •Critical Care Beds Harford Memorial will be closing ICU; Derth of beds in northern counties.
