# Discussion of requirement for active National Registry Certification prior to taking the Protocol Exam - Rae Oliviera

Previously, MIEMSS required that applicants for paramedic licensure had active status with National Registry prior to taking the protocol exam.

This requirement has been relaxed to allow for clinicians with inactive National Registry status, such as applicants for reciprocity, to take the protocol exam; however, licensure will not be granted until the applicant obtains active status.

The guidelines for clinicians with provisional licenses to obtain non-provisional licensure are attached in Appendix C.

# Renewal Courses Required for Clinicians Expiring 2021

The 2020 state content renewal courses have been waived through 2021.

Jurisdictions may continue to offer the three face-to-face courses in person or F5 format; however, these courses are currently being converted to an

online format that will be available this year. A formal memo will be released following completion of the conversion.

When the courses become required, ALS clinicians will need to take them regardless of the method of recertification used (i.e., challenging the National Registry exam instead of taking a traditional ALS refresher).

The requirements to teach the face-to-face courses are that the instructor is a paramedic in good standing with the EMSOP and that the paramedic is authorized by the EMSOP to teach paramedics.

#### OR

- Successfully complete a MIEMSS-approved Protocol Review Session within 180 days after termination of the Governor's proclamation of a state of emergency and catastrophic health emergency;
- Pass the NREMT Paramedic cognitive exam within 180 days after termination of the Governor's proclamation of a state of emergency and catastrophic health emergency; and
- Pass NREMT Paramedic psychomotor exam and document current, non-provisional status registration as a NREMT Paramedic by December 31, 2021.
