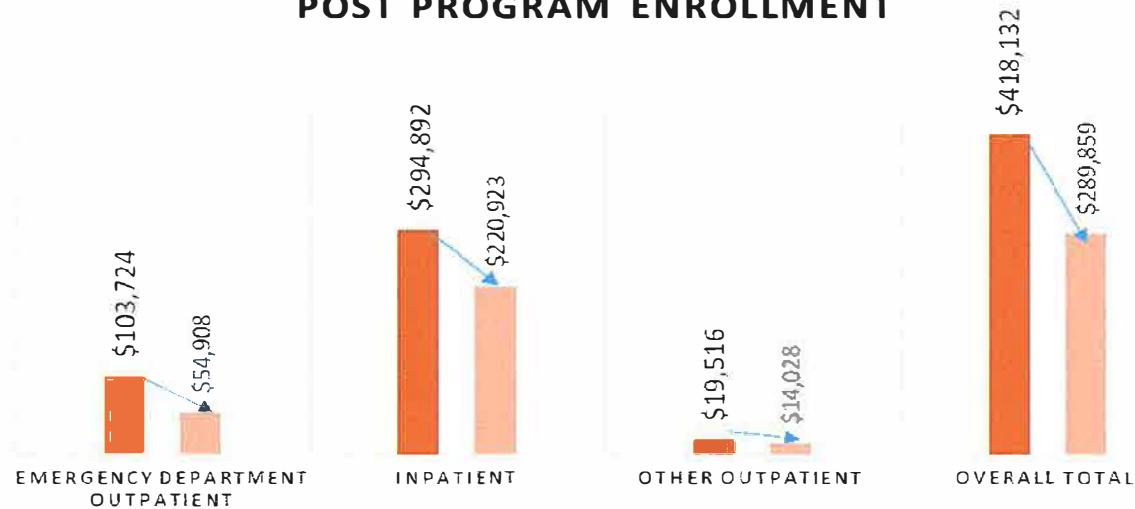

### MICH PATIENT HOSPITAL COSTS: 30 DAYS PRE VS POST PROGRAM ENROLLMENT



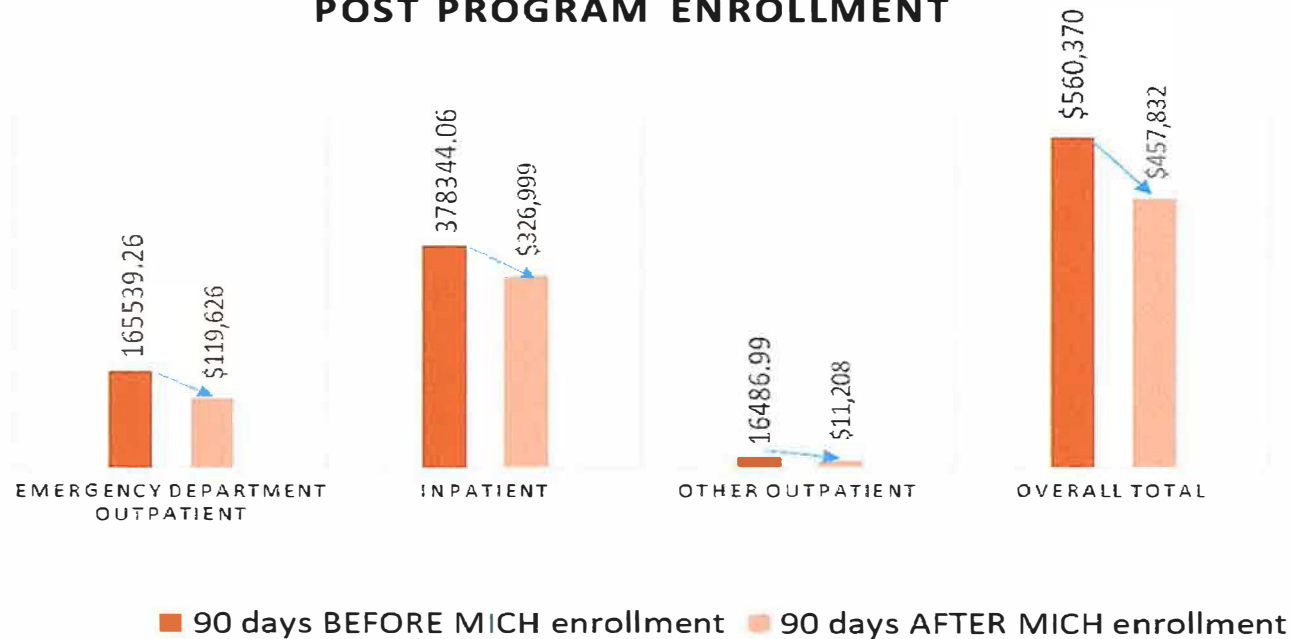

### MICH PATIENT HOSPITAL COSTS: 90 DAYS PRE VS POST PROGRAM ENROLLMENT

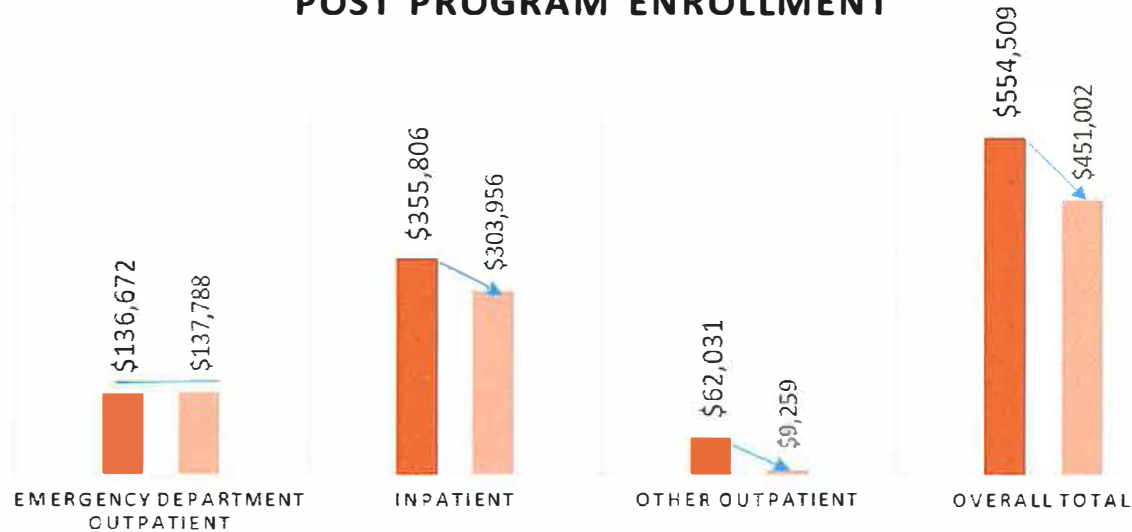
