I. Welcome & Introductions: Chief Chad Packard welcomed everyone to the meeting and introductions were done in the conference room and for the participants online.

II. Chair Report: The minutes from the September 28, 2016 meeting were reviewed. A motion to approve the minutes were made by Terrance Baker and seconded by Christian Griffin. The motion passed. There was no correspondence to report. The next meeting is scheduled for Wednesday, January 27, 2017 at 1:00pm in MIEMSS, Room 212.

III. Program Reports

A. SEMSAC/Legislative Update - Roger Simonds:

1. Roger was not present for the meeting; no report was given.

B. State EMS Medical Director Report - Dr. Richard Alcorta:

1. There is an ongoing search for MIEMSS Executive Director. In and out-of-state applicants are welcome to apply.
2. Phil Hurlock has returned as the Ombudsman part-time until the position is filled. Phil will be at essential meetings as MIEMSS liaison.
3. Licensure tool is now operational. It will help for tracking for all EMS providers. Providers would need to go to update and complete their profile to access the new system. This is currently not mandatory.

4. There are no legislative initiatives for Fire/EMS at this time.
5. There are concerns and interest in legislation for modification of downgrading hospitals to free standing medical facilities.
6. The 2017 protocol rollout for the LMS piece and the education contract will be more user-friendly. For the hospitals, they will be able to access it online in an video based process.
7. Elite Platform – MIEMSS is working with ImageTrend, CARES and the IT staff to finalize the CARES model within the platform. The timeline for completion is tentatively sometime in the summer of 2017.
8. A Tactical EMS Meeting will take place on Friday, December 9th from 10am to 12pm in Howard County. For anyone interested or requesting information should contact the Office of the Medical Director.

C. MIEMSS Region III Report - Jeff Huggins:

1. The Region III written report was distributed at the meeting and electronically and in meeting. The updated list has been sent out to the jurisdictions to create user rights for affiliations for the licensure tool. Hospitals that want to enter ConEd need to request an account and complete on their own. Jeff Huggins is the contact for questions and concerns.

D. Maryland EMSC Report - Cyndy Wright Johnson

1. The Maryland EMSC report was distributed at the meeting and electronically.
2. The education conference list for 2016-2017 is online. There is still one conference left in 2016: December 9th at Holy Cross Hospital – Advances in PEM. All conferences for 2017 are listed including a Pre-conference PEPP course in Winterfest, a standalone PEPP Hybrid course in St. Mary's County in February, an EMS Pediatric Vascular Access course at Miltenberger in March, two pre-conferences courses at EMS Care in April, a 2-day PALS Course in Upper Chesapeake. PEMAC is working on protocols and will have meetings over the next 6 months on pediatric CPR, commercial ambulance, BIPAP and CPAP meetings in January and pediatric ventilators in March. The recent Research Forum was well attended. Information was reported on ALS airway management, pathway for MRI to use for emergency departments for pain. The physicians APLS courses in September and November was well attended. The course will be rescheduled in 2017. Nominations are being accepted for The Right Care When it Counts and Maryland's Stars of Life awards. The nominations are due on April 7, 2017. Forms will be available for the January meeting.

E. MIEMSS Emergency Operations - Randy Linthicum

1. Planning is ongoing for the 2017 Presidential Inauguration. Washington DC has reached out to their MWCOC partners. There has been no declaration for staff at this time.
