Home Fire Prevention Techniques Courtesy of The State Fire Marshal



As winter descends and the temperatures get colder, many Marylanders are looking for ways to stay warm. State Fire Marshal Brian S. Geraci offers Marylanders a valuable fire prevention safety checklist to help stop fires before they occur inside the home. Address any items on this list promptly to ensure your family's safety during the upcoming winter months.

- Install and maintain smoke alarms on every level of your home. Test and vacuum monthly. Change batteries every year. Replace smoke alarms every ten years.
- Keep bedroom doors closed when sleeping. If a fire occurs elsewhere in the home, the closed door will provide additional time to escape by blocking heat, smoke, and toxic gases.
- If smoking materials are used, use a deep ashtray and smoke outdoors. Always ensure smoking materials are completely extinguished when finished.
- Keep all matches and lighters out of reach of children. Instruct children to alert an adult if they locate matches or lighters and not to touch them.
- Never leave a burning candle unattended. Avoid using candles in bedrooms and sleeping areas. Extinguish candles when you leave a room. Keep children and pets away from burning candles. Consider using

battery-operated flameless candles, which can look, smell, and feel like the real thing.

- Replace frayed, cracked, or otherwise damaged electrical cords.
- Limit use of extension cords and don't overload electrical circuits.
- Never run electrical cords under carpet or rugs.
- Keep the stovetop clean and remove any combustible items on or near the stove area.
- Never leave cooking food unattended. Turn off the stove if you need to leave the room.
- Have chimneys cleaned and inspected before use.
- Never use an accelerant in a fireplace or woodstove.
- Burn only seasoned, dry wood to help prevent creosote build-up in chimneys and woodstoves.
- Keep combustibles three feet away from all heating appliances, woodstoves, and fireplaces.
- Portable space heaters must be plugged directly into an outlet. Never use an extension cord or multiple plug power strips, as they may overheat and cause a fire.
- Have your furnace checked and cleaned for proper operation.
- Check the clothes dryer exhaust duct and ensure lint build-up is removed. Replace the duct with non-combustible ducting where applicable.
- Vacuum bathroom exhaust fans to eliminate dust build-up on the motor and fan blades.
- Keep flammable liquids in tightly sealed containers and store away from sources of heat.
- Plan and practice your home fire escape plan at least twice a year. Know two ways out of every room. Have a predetermined meeting location outside. Get out and stay out!

- If a fire occurs inside your home, close doors as you escape, if safe to do so, to help contain the fire.

A law became effective on July 1, 2013, involving "battery only" smoke alarms used in Maryland residential properties. When these "battery only" smoke alarms have reached their 10-year life span, they need to be replaced with new, long-life sealed lithium

Fire Rescue Organizational Guidance Seminar Held in Ocean City

The Maryland Fire Chiefs Association and the Maryland State Firemen's Association Recruitment and Retention Committee recently sponsored a Fire Rescue Organizational Guidance (FROG) seminar in Ocean City. Students from around the state attended this well-received two-day course.

Seminar participants worked together to develop solutions to common leadership challenges through scenario role play and discussions. Topics included analyzing and understanding fire department personnel, processes, and culture. Participants were able to customize practical guidelines that could be implemented at their home stations.

Information on 2017 seminars occurring across Maryland will be announced soon.



New MIEMSS Licensure System Update

We continue to encourage all providers and administrators to access the system to assure their contact information is correct if they have not already done so, or whenever there is a change in their status (eg, new mail delivery address, new email address, name changes). Email notification from the MIEMSS Licensure System is the primary method of contact; therefore, all providers and administrators must assure that this demographic item in particular is updated as necessary.

A great deal of activity has taken place since the new MIEMSS Licensure System has been open to providers and administrators. Nearly all system applications are now available to providers and administrators, including:

- Initial provider application (for new providers/students or for current providers to upgrade provider level)
- Renewal application for current providers
- Change of information (eg, address)
- Extension request
- Reciprocity application for providers new to Maryland
- Reinstatement application for lapsed providers
- Request to surrender licensure or certification
- Replacement card request
- Course request application for administrators

MIEMSS is in the process of enabling access to service/affiliation personnel records to designated administrators. Once that process is complete, Affiliation Request applications will be available on the MIEMSS Licensure System. We project the process to be completed and the application to be available to current and new providers by the end of January 2017. Additional applications that will be available soon are ePINS Request and Affiliation Drop Request.

battery smoke alarms with silence/hush button features. The silence/hush button feature temporarily disables the alarm so the occupant can ventilate the space from mild smoke conditions typically created during some cooking operations. The use of these alarms eliminates the need to replace the batteries during the 10-year life of the alarm.

If your property is protected with 120-volt electric smoke alarms, they also should be replaced every 10 years with new 120-volt smoke alarms with battery back-up to ensure proper and timely operation in the event of a fire.

Emergency Services Support the Third Annual Across the Bay 10K


On Sunday, November 6, 2016, nearly 21,000 participants crossed the Chesapeake Bay Bridge for the third annual Across the Bay 10K race. There were multiple agencies and organizations that made this a safe and successful event. EMS professionals from eight counties were on hand to support the event. The primary agencies providing assistance were Anne Arundel Fire Department, Caroline County Department of Emergency Services (DES), Cecil County DES, Charles County DES, Queen Anne's County (QAC) DES, Talbot County DES, Ocean Pines VFD, Queenstown VFD, Kent Island VFD, Sudlersville VFC, and Crumpton VFD.

The QAC DES led the coordination of the medical component of the race. They were supported by QAC Public Schools, QAC Department of Social Services, QAC Department of Health, Anne Arundel Medical Center, Shore Health – University of Maryland Shore Regional Health, and Anne Arundel Alarmers Food Services. State support was furnished by representatives from both MIEMSS and the Maryland Emergency Management Agency. Law enforcement staffing included the Maryland State Police, Maryland Transportation Authority Police, QAC Office of the Sheriff, and Anne Arundel County Police. There were multiple representatives from various federal agencies as well.

This Month's CARES Tip


If a cardiac arrest occurs before the arrival of EMS, it is considered to be witnessed if it was either **seen or heard** by a layperson. If the layperson hears a "thud" coming from another room, goes immediately into that room, and sees that the patient is unresponsive/unconscious, then the arrest should be considered witnessed. If the arrest occurs after the arrival of EMS, a first responder or provider must be at the patient's side for the arrest to be considered witnessed. If the arrest was neither seen nor heard, it is considered unwitnessed.

If you are the provider filling out the Cardiac Arrest-CARES tab on the PCR, please check with any first responders/providers who were on the scene to see if the arrest was indeed witnessed and who it was witnessed by, so that you can fill out the data element "Arrest Witnessed? (CARES-19)" accordingly.



Q: I am due to renew my certification, but I cannot recall if I have completed all the required continuing education. How can I find out?

A: The best way to keep track of your certification and your continuing education on file at MIEMSS is to access the MIEMSS Licensure System. You may do so through the MIEMSS homepage and clicking the Provider Login button, or directly at www.miemsslicense.com. After logging in, select the Training button, and then select Report. The system will default to your provider level and current certification cycle date range. The courses taken during that cycle will be displayed by selecting the PDF icon (next to your provider level—see below).



You can change the record displayed by changing the date ranges and the level to All Training Levels. You can also print the PDF document. If you have questions about your certification or continuing education, please contact the Office of Licensure and Certification at 800-762-7157.

Staged Incident Demonstrates Importance of Move Over Law

On December 1, 2016, more than 15 agencies and 150 personnel from across Maryland gathered on a section of Dorsey Run Road in Howard County to stage a mock incident as a training exercise. The simulation included an overturned tractor trailer leaking hazardous materials.


On Maryland highways, it takes police or state highway personnel an average of 12 minutes to arrive at an incident and approximately 23 minutes to reopen the travel lanes. Keeping traffic moving and quickly clearing incidents is dangerous for highway personnel, police, fire and rescue,

and hazmat crews. Dozens of first responders are injured on highways every year. “The men and women of the Maryland State Highway Administration (SHA) work every day to clear incidents from some of the busiest roads in the country. Even with the Move Over law in place, first responders continue to be struck by drivers not paying attention,” said SHA Administrator Gregory Johnson, PE. “We must all give full attention to driving. Anything less can literally be a life or death decision.”

The mock incident on Dorsey Road highlighted the importance of attentive driving and the Move Over law. “The clear purpose behind Maryland’s Move Over law is to save the lives of our police officers, emergency service providers, and our tow service operators while working the scene of an incident,” said Captain Dan Pickett, Troop Commander for the Maryland State Police Washington Metro Troop. “If moving to another lane is not possible, the law requires drivers to slow down to a reasonable speed. This law provides an extra barrier of safety necessary for all emergency personnel to focus on assisting people at the scene.”

In the event your vehicle become disabled or you are involved in a crash:

- Move your vehicle as far off the road as possible.
- Call #77 on Maryland interstates to reach the nearest State Police barrack, or 9-1-1 in the event of a crash that involves any injury.
- If your vehicle is disabled, stay in the vehicle and remain buckled once you are safely off the road.
- Do not under, any circumstances, become a pedestrian and put yourself in danger.
- Always place children in the proper child safety seats.
- As a reminder, always *Move Over* into the next lane or slow down when passing emergency responders and tow trucks on the shoulder. It is Maryland law.

Safe Holiday Decorating

According to Project Holiday from the National Fire Protection Association (NFPA), more than 800 fires a year begin with decorations and another 200 start with holiday trees.

Be fire smart as you deck the halls for a festive holiday season with these NFPA tips:

- Be careful with holiday decorations. Choose decorations that are flame resistant or flame retardant.
- Keep lit candles away from decorations and other things that can burn.
- Use indoor and outdoor lights appropriately. Some lights are only for indoor or outdoor use, but not both.
- Replace any string of lights with worn or broken cords or loose bulb connections. Read manufacturer's instructions for the maximum number of light strands you can connect.
- Use clips, not nails, to hang lights, so the cords do not get damaged.
- Keep decorations away from windows and doors.

Following these holiday tree safety tips, courtesy of www.fireadvocates.org, can help keep your festivities safe and enjoyable:

- When you purchase a live tree, make sure it is fresh. Needles should be green and springy to the touch.
- Cut 1 to 2 inches off the bottom of the trunk before placing the tree in the stand. A fresh cut allows the tree to absorb water. Place the tree in water right away.
- Fill the tree stand with water every day.
- Make sure the tree is at least 3 feet away from any heat source, like floor vents, fireplaces, radiators, candles, or lamps.
- Make sure your tree is not blocking an exit.
- Always turn the tree lights off or unplug them before going to bed or leaving your home.
- Use lights that are approved by a national testing organization like UL.
- Remove your tree immediately after the holidays, even if you think it is not dry.
