## Miltenberger Emergency Services Seminar 2023

**THE 18<sup>TH</sup> MILTENBERGER EMERGENCY SERVICES SEMINAR** drew approximately 150 EMS, Fire, Law Enforcement, and Public Safety personnel from across Western Maryland and around the state to Rocky Gap Casino Resort in Flintstone, Maryland, March 9-11, 2023.

This year's diverse array of workshops provided continuing education opportunities for a variety of disciplines, including EMS, Nursing, Fire, and Dispatch. Pre-conference programming included the PEPP-4 Hybrid Course for ALS and BLS clinicians, designed by the American Academy of Pediatrics and administered by the MIEMSS EMS for Children Department, which focuses on assessment and management of ill or injured children. Other pre-conference offerings included a daylong 12-Lead ECG Interpretation Workshop; a multifaceted Nursing/ALS Program; a Stop the Bleed<sup>®</sup> Clinician Instructor Course; and Dispatch track focusing on "Expecting the Unexpected".

During his state of Maryland EMS address, MIEMSS Executive Director Dr. Ted Delbridge told attendees that Maryland's formal EMS system, which celebrates its 50<sup>th</sup> anniversary this year, "stands out" as a national model "because of you and the work you do every day."

critical care resources when patient transfers are necessary.

Donald Lehman, a retired Maryland State Police Trooper/Medic who now serves as Lead Paramedic Instructor for the Washington County Department of Emergency Services, emphasizes the importance of programming like the Miltenberger Emergency Services Seminar to professional development. "I tell my students [that] how you continue

■ **Allegany County EMS Records Fastest 9-1-1 Response Times in County's History** (*Fox 45 Baltimore*). Despite the inherent challenges that rural emergency medical services face, under Director of Emergency Services James Pyles, Allegany County EMS has pared its average 9-1-1 response time to less than 10 minutes, the fastest in its history. ■ **MDH Announces Expanded Educational Loan Repayment Programs for Healthcare Professionals** (*Maryland Department of Health*). The Maryland Department of Health has announced the largest expansion of the Maryland Loan Repayment Program (MLRP) for the 2023 application cycle. In exchange for service obligations to practice in areas of healthcare professional

shortage, eligible health care providers and support staff can earn higher education loan repayment assistance from \$5,000 to \$100,000, depending on licensure. Broadened legislative authority and greater state and federal resources will allow applications from an expanded pool of healthcare professionals, including full and part-time physicians, physician assistants, nurses, and nursing support staff. ■ **FDA Approves First Over-the-Counter Naloxone Nasal Spray** (*US Food and Drug Administration*). On March 29, the FDA approved Narcan, 4 milligram (mg) naloxone hydrochloride nasal spray for over-the-counter (OTC), nonprescription, use – the first naloxone product ap-

proved for use without a prescription. The FDA's action paves the way for the life-saving medication to reverse an opioid overdose to be sold directly to consumers in places like drug stores, convenience stores, grocery stores and gas stations, as well as online. ■ **Fire and EMS: Be Alert for Alternative Fuel Vehicle Conversions** (*US Fire Administration*). As alternative fuels become increasingly popular, many vehicle owners are opting for professional and home conversions that change fossil fuel-powered vehicles into vehicles that run on alternative fuels. It's important for all first responders to be aware of alternative fuel conversions because vehicles powered by anything other

# Notice of Funding Opportunity for 2023 Rural EMS Training Grant Program

*Applications Due May 1, 2023*

**THE SUBSTANCE ABUSE AND MENTAL HEALTH SERVICES ADMINISTRATION (SAMHSA)**, part of the U.S. Department of Health and Human Services, has announced a Notice Of Funding Opportunity (NOFO) for the 2023 Rural EMS Training Grant Program. There have been important revisions to the amount of funding available and the anticipated number of awards that will be granted.

SAMHSA encourages rural EMS agencies (both fire-based and non-fire based) operated by a local or tribal government, as well as rural non-profit EMS agencies, to apply.

training program, eligibility information and award details. All applications are due May 1, 2023.

The goal of this SAMHSA program is to recruit and train EMS personnel in rural areas with a particular focus on addressing substance use disorders (SUD) and co-occurring disorders (COD) substance use and mental disorders. Grant recipients will be expected to train EMS personnel on SUD and COD, trauma-informed, recovery-based care for people with such disorders in emergency situations and, as appropriate, to maintain licenses and certifications relevant to serve in an EMS agency.

"GCS is less than 8 means you intubate" - a gross oversimplification of perhaps the most difficult aspect of airway management, that being the decision to take over and manage a patient's airway. Not to mention, it incorrectly orients clinicians only to consider airway management in those that meet that GCS threshold, despite it being well-established that there are patients who present with a GCS greater than 8 that often do require airway management. To the novice airway practitioner, this "GCS rule" may seem to be a great mental shortcut to avoid all of the agonizing over whether or not to intubate a patient. This presentation will offer attendees a new mental model to use to approach the decision to intubate/manage an airway.

However, other times it is essential to understand the transition from intrauterine to extrauterine life and know the key steps to take – in the correct order. This team of experts will emphasize the principles of neonatal resuscitation and stabilization as they apply in the out-of-hospital or within interfacility environments. The team will review how to estimate gestational age, and introduce the participants to MR. SOPA, and the actions needed to keep the newly born infant STABLE.

# Progress of the Public Access Trauma Care Program

**THE PUBLIC ACCESS TRAUMA CARE (PATC)** program has expanded equipment distribution and training opportunities in Montgomery and Prince George's Counties. These initiatives will increase the accessibility of medical equipment to allow individuals to render life-saving medical aid to injured patients.

Injuries that result in traumatic bleeding events can occur in various settings throughout communities. Automobile collisions, workplace accidents, construction mishaps, sports injuries, penetrating trauma, and other medical events can all lead to significant blood loss. A victim suffering from a major bleeding incident may potentially bleed out before the arrival of medical professionals. The Maryland-National Capital Region Emergency Response System (MDERS) developed the PATC program to provide civilians with the requisite knowledge, skills, abilities, and equipment to treat life-threatening injuries.

A PATC individual kit contains the medical supplies to treat major bleeding injuries, pneumothorax, and hypothermia. The kit contains a Combat-Application-Tourniquet (C-A-T), emergency trauma dressing, compressed gauze, medical gloves, trauma shears, chest seals, a Mylar® blanket, a permanent marker, a mini duct tape roll, and an instruction card. Five kits and a patient movement device are placed in a durable bag located in an accessible cabinet.

MDERS has coordinated with regional partners on the installation and placement of these medical supplies throughout the Maryland-National Capital Region (MD-NCR). In the last year, PATC 5-pack kits have




been placed in Montgomery College, Prince George's County Public high schools, Prince George's County government buildings, and University of Maryland Global Campus facilities. Planned installations will occur later this year in Montgomery County government buildings and at the Universities at Shady Grove. The totality of these distributions exceeds 1,000 PATC 5-pack kits provided to our regional partners to create an immediate medical response capability to treat time-sensitive injuries.

In conjunction with the allocation of PATC 5-pack kits, MDERS has developed and procured training materials to educate the public to identify and treat medical emergen-

cies. Five training videos were created to show viewers how to apply a chest seal, apply direct pressure, apply a tourniquet, maneuver a victim into the recover position, and pack a wound. A training presentation was created and provided to regional partners to allow for instruction on the basic medical steps needed to render proper aid to injured individuals. To support these trainings and promote hands-on practice with the PATC medical supplies, MDERS has established a training cache that can be utilized by our partners. MDERS has also acquired a training cache for Montgomery County Public Schools and will soon supply a training cache Prince George's County Public Schools to teach students about the basic medical skills associated with the PATC program.

MDERS will continue investments in equipment and training for the PATC program will help promote prompt medical intervention by civilians to render life-saving medical aid. This award is intended for citizen rescuers who have demonstrated quick thinking, fast action, and heroism.

### **EMS CLINICIAN OF THE YEAR**

This award recognizes a clinician who has made outstanding contributions in the past year to the continuous improvement of emergency medical services in Maryland (for example, in the areas of quality assurance, public or EMS education, prevention, delivery of EMS services, and new technology).

### **EMD CLINICIAN OF THE YEAR**





The National American Trauma Society (ATS) has joined the White House and other trauma and emergency care partners in the “Stop the Bleed” campaign. This important initiative provides bystanders at emergency situations with the tools and knowledge to stop life threatening bleeding. No matter how rapid the arrival of emergency medical services (EMS), bystanders will always be first on the scene. A person who is bleeding can die from blood loss within five minutes, therefore it is important to quickly stop the blood loss. "Stop the Bleed" is a nationwide campaign to empower individuals to act quickly and save lives. Working with the private sector and nonprofit organizations, this campaign directs knowledge gained by first responders and our military, into the hands of the public to help save lives. The ATS, Maryland Division is looking to help build both national and statewide awareness of the campaign and the important role bystanders can play in saving lives.

In order to assist in the implementation of this critically important program, the ATS, Maryland Division will be providing three grants in the amount of \$2,500 to EMS personnel at the jurisdictional level or individual EMS companies in Maryland. These funds may be used to promote the training of Marylanders in the Stop the Bleed program. By providing these funds to Maryland’s EMS personnel, the ATS is working to increase the training across the state. The ATS feels that the EMS community plays an important role in this important educational effort. These funds may be used in a variety of ways to either start or enhance programs. Training materials, promotional materials, and actual bleeding control kits are all ways that the funds may be spent. All Maryland EMS jurisdictional programs, individual EMS companies, and Fire/EMS departments are eligible to apply. The grant proposals will be judged on their merit by members of the ATS, Maryland Division Board. They will be looking for specific details in the proposals such as number of bleeding control kits purchased, number of community members trained, or number public employees trained. **All grant proposals must be received by April 30, 2023.** Award winners will be notified during the summer of 2023.

The ATS, Maryland Division looks forward to assisting Maryland’s emergency medical services with this critical endeavor as we better prepare our state for these types of emergencies. The American Trauma Society is a voluntary, non-profit organization dedicated to preventing traumatic injuries and reducing their consequences. The main missions of the ATS are to provide injury prevention information through public education and to serve as leaders in the development, advocacy, and maintenance of trauma systems.

with the most modern, up-to-date education and protocols and patient treatment is by going to conferences like this, because you get the cutting-edge,” says Lehman.

UPMC Western Maryland Director of Emergency Medicine and Allegany County EMS Medical Director Dr. Rameen Shafiei, who presented a session on trauma airway management, concurs. “Keeping your skills honed if you’re not taking care of a trauma or doing an intubation every day” can be challenging for EMS clinicians in such a sparsely populated region, explains Shafiei. Moreover, taking part in a program on the scale of Miltenberger also “makes you feel like you belong, like you’re really part of the family of the Maryland EMS system.”

educator in the emergency department at Meritus Medical Center in Hagerstown, Maryland, takes advantage of the continuing education opportunities that Miltenberger affords her team. “Even being an old nurse, I learned a couple new things,” quipped Moser, who sent nearly 10 members of her team to this year’s conference.

At the end of the day, the Miltenberger Emergency Services Seminar

also offers a chance for partners like Baltimore’s R Adams Cowley Shock Trauma Center (RACSTC) to “close the loop” with local EMS clinicians regarding what ultimately becomes of their patients, according to RACSTC Trauma Program Manager Rebecca Gilmore, MSN, RN, TCRN. “Giving them that information, I think, is useful for both sides,” says Gilmore. “We can’t do what we do without them.” ■

assists have been generated. C4 is staffed with two (2) critical care coordinators and a Central Intensivist Physician (CIP) 24/7. Any Maryland hospital with a patient needing a critical care transfer or treatment guidance can contact the C4 at 410-706-7797 and select Option #1 to be connected with the Adult ICU coordinator and physician team. The C4 coordinator has a near-real time view of statewide hospital critical care bed capacity. The CIP then works with referring physicians to identify patients’ anticipated critical care needs. The C4 coordinator and CIP, working jointly with the sending and receiving facilities, match the patients with available criti-

cal care resources that can manage the patients’ conditions.

MIEMSS subsequently expanded the C4 to include Pediatrics, accessed by calling 410-706-7797 and selection Option #2, which connects the caller with the Pediatric coordinator and pediatric emergency care and critical care physician team. “C4-Pediatrics” provides an EMS Coordinator and Central Advisor Pediatric Physician available 24/7 by phone. C4-Pediatrics provides consultation and facilitates the transfer of patients requiring a Pediatric Intensive Care Unit or Pediatric Acute Care Unit utilizing the intensive care bed surveillance system at MIEMSS. Efforts are underway for a statewide tour to promote the CH this fall. ■
