- I. **Welcome & Introductions:** Chief David Sabat welcomed everyone to the meeting.

A. Mustafa Sidik showed a presentation discussing transfer of care times. Off load times at Shock Trauma recently were over 30 minutes and some after 90 minutes. Data from the past two weeks from all hospitals in Region III show that there has been 406 records that the transfer of care is more than 30 minutes to get a bed and back in service is less than a minute. Howard County has to depend on providers and monitor their times because their radios don't work there. Anne Arundel County uses their radio button to report their times. MIEMSS will continue to monitor the data and review what the metrics should be.

E. BWI

- 1. Working on placing 2 personnel over to terminal project for 16 hours a day and will begin on Monday, November 20th
- 2. Remove EMS Officer from the transport unit
- 3. Hiring process for 24 paramedics, join the class starting in February 2024

F. Carroll

- 1. Improving on the transfer of care times
- 2. Process of hiring 10 additional paramedics and will be able to add 2 per shift

G. Harford

- 1. 17th medic unit in service in the next two weeks
- 2. 2nd EMS captain within two weeks

H. Howard

- 1. Howard County General Hospital had two people were shot and showed up at the front door of the ER. There were just finishing 2 medical cardiac arrests. The hospital went on lockdown and could not see anyone and started a mini-disaster.

- 3. Harford Memorial Hospital in Havre de Grace is shutting down and transferring to the Aberdeen Freestanding site University of Maryland Upper Chesapeake Aberdeen on February 6, 2024.
